this collective volume has been dedicated to two distinguished scholars of neo latin studies on the occasion of their retirement after a long and fruitful academic career one at the université catholique louvain la neuve the other at the internationally renowned seminarium philologiae humanisticae of leuven university both the rich variety of subjects dealt with and the international diversity of the scholars authoring contributions reflect the wide interests of the celebrated neo latinists their international position and the actual status of the discipline itself ranging from the trecento to the 21st century and embracing latin writings from italy hungary the netherlands germany france poland the new world spain scotland denmark and china this volume is as rich and multifaceted as it is voluminous for it not only offers studies on well known figures such as petrarch lorenzo valla erasmus lives thomas more eobanus hessus lipsius tycho brahe jean de la fontaine and jacob cats but it also includes new contributions on renaissance commentaries and editions of classical authors such as homer seneca and horace on neo latin novels epistolography and renaissance rhetoric on latin translations from the vernacular and invectives against napoleon on the teaching of latin in the 19th century and on the didactics of neo latin nowadays

this book explores the relationship between diverse social movements and marxist historical cultures during the second half of the twentieth century in western europe with special emphasis on the federal republic of germany and italy during the cold war marxist ideas and understandings of history informed not only the traditional communist parties in western europe but also influenced a range of new social movements that emerged in the 1970s in the wake of the 1968 student rebellions the generation of 1968 was strongly influenced by neo marxist ideas that they subsequently carried into the new social movements the volume asks how marxist historical cultures influenced third world movements anti fascist movements the peace movement and a whole host of other new social movements that signaled a new vibrancy of civil society in western europe from the 1970s onwards

this book aims to promote a simple idea that in the contemporary context of the study and interpretation of classical literature at universities traditional classical scholarship and modern theoretical ideas need to work with each other in the common task of the interpretation of texts such dialogue and co operation is not merely desirable it is essential to ensure the survival and relevance of the study of classical literature in the twenty first century the purpose of this book is protreptic to speak both to the sceptical and non sceptical and to suggest to both the importance of the topic the topics selected were chosen by a panel of distinguished practitioners as traditional areas of classical literary studies where the importance of co operation of theory and scholarship could be shown in different ways by scholars who ranged widely in their views literary language narrative genre historicism and reception and history of scholarship

euro librarianship focuses on strategies for working toward cooperation between libraries throughout europe and the united states to provide the best access and information to research materials as possible chapters by several authors in their original languages with english abstracts give this book a unique international appeal common difficulties such as fiscal constraints and rising book and serial prices are discussed stressing enhanced communication and shared responsibilities this new volume helps bring libraries of all countries closer to the resource sharing capabilities that allowa scholars and researchers much wider access to information than is available today in this timely new book many of the papers that were presented at the second western european specialists wess international conference are brought together to be read and studied by everyone

twelve years have gone by since the passing of george l mosse yet his work still provides essential tools for historical analysis and influences contemporary research this volume provides a re examination of his historiographical production and an analysis of his influence in the context of italian history

this book examines the evolving representations of the colonial past from the mid 19th century up to decolonization in the 1960s and 70s the so called era of modern imperialism in post war history textbooks from across the world the aim of the book is to examine the evolving outlook of colonial representations in history education and the underpinning explanations for the specific outlook in different former colonizer and colonized countries to be found in collective memory popular historical culture social representations identity building processes and the state of historical knowledge within academia the approach of the book is novel and innovative in different ways first of all given the complexity of the research an original interdisciplinary approach has been implemented which brings together historians history educators and social psychologists to examine representations of colonialism in history education in different countries around the world while drawing on different theoretical frameworks secondly given the interest in the interplay between collective memory popular historical culture social representations and the state of historical knowledge within academia a diachronic approach is implemented examining the evolving representations of the colonial past and connecting them to developments within society at large and academia this will allow for a deeper understanding of the processes under examination thirdly studies from various corners of the world are included in the book more specifically the project includes research from three categories of countries former colonizer countries including england spain italy france portugal and belgium countries having been both colonized and colonizer chile and former colonized countries including zimbabwe malta and mozambique this selection allows pairing up the countries under review as former colonizing colonized ones for instance portugal mozambique united kingdom malta allowing for an in depth comparison between the countries involved before reaching the research core three introductory chapters outline three general issues the book starts with addressing the different approaches and epistemological underpinnings history and social psychology as academic disciplines hold in a second chapter evolutions within international academic colonial historiography are analyzed with a special focus on the recent development of new imperial history a third chapter analyses history textbooks as cultural tools and political means of transmitting historical knowledge and representations across generations the next ten chapters form the core of the book in which evolving representations of colonial history from mid 19th century until decolonization in the 1960s and 1970s are

examined explained and reflected upon for the above mentioned countries this is done through a history textbook analysis in a diachronic perspective for some countries the analysis dates back to textbooks published after the second world war for other countries the focus will be more limited in time the research presented is done by historians and history educators as well as by social psychologists in a concluding chapter an overall overview is presented in which similarities and differences throughout the case studies are identified interpreted and reflected upon

eduard meyer 1855 1930 was among the most important historians of his age after mommsen he is the best known german ancient historian from 1902 he taught ancient history in berlin and from 1919 20 he was vice chancellor his most important work geschichte des altertums includes the ancient oriental cultures contains a sociological anthropological methodology and considers all humane studies especially religious history this collection treats aspects of meyer s biography including his journey to america his relations with his contemporaries m weber o spengler u von wilamowitz his university politics his role in the first world war his positions on christianity and judaism history of philosophy and particular research results and their effect

this is the first in depth study of the feminist movement that swept italy during the long 1970s 1968 1983 and one of the first to use a combination of oral history interviews and newly released archive sources to analyze the origins themes practices and impacts of second wave feminism while detailing the local and national contexts in which the movement operated it sees this movement as transnationally connected emerging in a society that was both characterized by traditional gender roles and a microcosm of radical political projects in the wake of 1968 the feminist movement was able to transform the lives of thousands of women shape gender identities and roles and provoke political and legislative change more strongly mass based and socially diverse than its counterparts in other western countries at the time its agenda encompassed questions of work unpaid care work sexuality health reproductive rights sexual violence social justice and self expression the case studies detailing feminist politics in three cities turin naples and rome are framed in a wider analysis of the movement s emergence its transnational links and local specificities and its practices and discourses the book concludes on a series of hypotheses regarding the movement s longer term impacts and trajectories taking it up to the berlusconi era and the present day

from the 1930s to the 50s in italy commercial cultural products were transformed by new reproductive technologies and ways of marketing and distribution and the appetite for radio films music and magazines boomed this book uses new evidence to explore possible continuities between the uses of mass culture before and after world war ii

a master historian illuminates the tumultuous relationship of il duce and his young lover claretta whose extraordinarily intimate diaries only recently have become available few deaths are as gruesome and infamous as those of benito mussolini italy s fascist dictator and claretta or clara petacci his much younger lover shot

dead by italian partisans after attempting to flee the country in 1945 the couple's bodies were then hanged upside down in milan's main square in ignominious public display this provocative book is the first to mine clara's extensive diaries family correspondence and other sources to discover how the last in mussolini's long line of lovers became his intimate and how she came to her violent fate at his side r j b bosworth explores the social climbing of claretta's family her naïve and self interested commitment to fascism her diary's graphically detailed accounts of sexual life with mussolini and much more brimful of new and arresting information the book sheds intimate light not only on an ordinary extraordinary woman living at the heart of italy's totalitarian fascist state but also on mussolini himself

the 15 papers in this volume delivered to an international conference held at the katholieke universiteit leuven in the fall of 2001 offer a systematic investigation into polybius's many critiques and attempt to assess their potentially distortive effects

edmondo lupieri's main goal in a commentary on the apocalypse of john is to introduce readers to the mental and spiritual world of john as both a first century jew

and a follower of Jesus the fruit of over ten years of research a constructive response to postmodern criticism and an academic best seller in its Italian edition Lupieri's commentary offers both new proposals and traditional interpretations to shed light on this complex coda to the biblical message in an illuminating preface Lupieri discusses the strange world of the apocalypse and promises an open commentary full of original treatments of knotty interpretive problems maintaining a strong historical perspective throughout he examines the text of the apocalypse line by line paying careful attention to the Greek text offering a new translation making wide use of apocryphal pseudepigraphal and Qumran literature and often analyzing John's apocalypse as compared to other Jewish apocalypses thoughtful thorough and nonsectarian Lupieri's commentary on the apocalypse of John will appeal to anyone with a serious interest in the meaning of the biblical text

What have the achievements of women's and gender history as a field of study been in Italy to what extent has it succeeded in making women's history an integral part of academic enquiry rather than an optional specialist area what impact has the study of manhood and masculinities had on our understanding of women's lives what is the relationship between gender studies and new critical histories of colonialism and empire contact zones cross cultural encounters and racialisation how is new work on cultural geography and spatial categories impacting our historical understandings of bodily differences the articles collected here are inspired by these questions previously posed by Karen Offen and Chen Yan to an international group of historians they discuss several critical themes including the challenges the field has experienced in the Italian institutional context and which it continues to face today how we can move the conversation beyond Italy and Europe to other international arenas and how to expand the research on topics like the history of masculinities gay and lesbian studies colonial studies and global history

This book represents a first attempt to investigate the relations between law and agroecology there is a need to adopt a transdisciplinary approach to multifunctional agriculture in order to integrate the agroecological paradigm in legal regulation this does not require a super law that hierarchically purports to incorporate and supplant the existing legal fields rather it calls for the creation of a trans law that progressively works to coordinate interlegalities between different legal fields respecting their autonomy but emphasizing their common historical roots in *rus* in the process *rus* the rural phenomenon as a whole reflects the plurality and interdependence of different complex systems based jointly on the land as a central point of reference rural is more than agricultural if agriculture is understood traditionally as an activity aimed at exploiting the land for the production of material goods for use consumption and private exchange rurality marks the reintegration of agriculture into a broader sphere one that is not only economic but also social and cultural not only material but also ideal relational historical and symbolic and not only private but also public in approaching *rus* the natural and social sciences first became specialized multiplied and compartmentalized in a plurality of first order disciplines later they began a process of integration into agroecology as a second order multi perspective and shared research platform today agroecology is a transdiscipline that integrates other fields of knowledge into the concept of agroecosystems viewed as socio ecological systems however the law seems to still be stuck in the first stage following a reductionist approach law has deconstructed and shattered the universe of *rus* into countless disjointed legal elementary particles multiplying the planes of analysis and in particular keeping agricultural law and environmental law two separate fields

this book explores the day to day lived experience of fascism in venice during the 1930s charting the attempts of the fascist regime to infiltrate and reshape venetians everyday lives and their responses to the intrusions of the fascist state

the italian neoavanguardia a literary and artistic movement characterized by a strong push towards experimentation playfulness and new forms of language usage was founded at the beginning of the 1960s by a group of poets critics artists and composers although the neoavanguardia movement has been primarily defined and examined in a literary context it is broadly discussed in this collection as also affecting other artistic forms such as the visual arts music and architecture in examining this often controversial movement neoavanguardia s contributors include topics such as critical theoretical debates the crisis of literature as defined within the movement and issues of gender in 1960s italian art and literature this important collection interrogates the arts as creative codes their ability to question reality and their capacity to survive in so doing it paves the way for future interdisciplinary investigations of this complex cultural formation

globalisation and historiography of national leaders symbolic representations in school textbooks the 18th book in the 24 volume book series globalisation comparative education and policy research explores the interrelationship between ideology national identity national history and historical heroes setting it in a global context based on this focus the chapters represent hand picked scholarly research on major discourses in the field of history textbooks and symbolic representations of national heroes and draw upon recent studies in the areas of globalisation history textbooks and national leaders a number of researchers have written on the importance of teaching national history in order to foster national identity and a sense of belonging to a certain society state and people among the younger generation some nations prefer to create national heroes out of their political leaders who are still in power and whose lives and reputation are portrayed as being eminently spotless using diverse comparative education paradigms from critical theory social semiotics and historical comparative research the authors analyse the unpacking of the ideological agenda hidden behind the choice and lionization or silencing of the preferred national heroes they provide an informed critique of various historical narratives depicting national leaders and national heroes the book provides an easily accessible practical yet scholarly source of information on international concerns in the field of globalisation history education and policy research offering an essential sourcebook of ideas for researchers history educators practitioners and policymakers in the fields of globalisation and history education it also provides a timely overview of current changes in politically correct history education narratives in history textbooks

this volume is the result of an international conference held at sapienza university in rome on june 20 and 21 2013 as the final stage of the prin progetto di rilevante interesse nazionale project empires and nations from the 18th to the 20th century during which scholars from all over the world academics specialists young

researchers phd students and post doctorates confronted diverse but connected topics on the relations between multinational empires and the idea of the nation in this way the reality of the historical empires and national states was represented and concepts such as identity nationality and sovereignty analyzed the second volume is dedicated to the age of empires and colonialism with particular reference to the colonial policy of the great powers england russia and italy the reality of post colonial states and to the different patterns of decolonization including specific cases such as south sudan azerbaijan iraq afghanistan and palestine particular attention is paid to the economic systems of different countries and to the area of southeastern europe particularly to romania and its multicultural area transylvania to the great war and the dissolution of the multinational empires ample space is dedicated providing insights on border issues ethnic conflicts foreign policies the adriatic question and the territorial conflict between yugoslavia and italy the final part of the book analyzes communism the bipolar system and the east west conflict that divided europe for almost half a century with specific contributions that discuss post communist nations and states

an exploration of the american role in italy prior to the decisive elections of 1948

this 2006 book is a controversial reappraisal of the italian occupation of the mediterranean during the second world war which davide rodogno examines within the framework of fascist imperial ambitions he focuses on the european territories annexed and occupied by italy between 1940 and 1943 metropolitan france corsica slovenia croatia dalmatia montenegro albania kosovo western macedonia and mainland and insular greece he explores italy s plans for mediterranean expansion its relationship with germany economic exploitation the forced italianisation of the annexed territories collaboration repression and italian policies towards refugees and jews he also compares fascist italy and nazi germany through their dreams of imperial conquest the role of racism and anti semitism and the fascistization of the italian army based on previously unpublished sources this is a groundbreaking contribution to genocide resistance war crimes and occupation studies as well as to the history of the second world war more generally

due to its internationality and interdisciplinarity the international oral history association ioha which was founded in the late 1970 s is one of a kind in the academic landscape driven by the desire to democratize historical scholarship its members wanted to give a voice to groups such as women workers migrants or victims of political dictatorships who had not been heard up to that point the contributions deal with the academic approaches and the political convictions of the previous generation

european macro regions euroregions and other forms of inter regional cross border cooperation have helped to shape new scenarios and new relational spaces which may generate opportunities for economic development while redefining the political and economic meaning of national borders this book is based on a number of key case studies which are crucial to understanding the complex web of political economic and cultural factors that shape the heterogeneous picture of europe s

new geography this book provides a fresh view on this phenomenon with a realistic approach shedding light on its complexity as well as on its ambiguities the new macro regions are interpreted with an approach recognizing the importance of institutionalization but also their flexible configuration and blurred borders the book also raises the issue of credibility and legitimacy arguing that inter regional cooperation has to be removed from the foggy realm of the exchanges between local political and bureaucratic elites in order to be clearly and concretely motivated and functional to key strategic objectives of the regions finally the authors suggest a complementarity between relations based on proximity and wider possibly global networks where some territories and especially metropolises find opportunities based on virtual proximity europe s changing geography provides a substantial re appraisal of a key phenomenon in the process of european integration today it will be of interest both to scholars of the political economy of european regionalism and to practitioners

the first historical appraisal of the astonishing life and times of a controversial twentieth century saint padre pio is one of the world s most beloved holy figures more popular in italy than the virgin mary and even jesus his tomb is the most visited catholic shrine anywhere drawing more devotees than lourdes his miraculous feats included the ability to fly and to be present in two places at once an apparition of padre pio in midair prevented allied warplanes from dropping bombs on his hometown most notable of all were his stigmata which provoke heated controversy to this day were they truly god given a psychosomatic response to extreme devotion or perhaps the self inflicted wounds of a charlatan now acclaimed historian sergio luzzatto offers a pioneering investigation of this remarkable man and his followers neither a worshipful hagiography nor a sensationalist exposé padre pio is a nuanced examination of the persistence of mysticism in contemporary society and a striking analysis of the links between catholicism and twentieth century politics granted unprecedented access to the vatican archives luzzatto has also unearthed a letter from padre pio himself in which the monk asks for a secret delivery of carbolic acid a discovery which helps explain why two successive popes regarded padre pio as a fraud until pressure from pio worshipping pilgrims forced the vatican to change its views a profoundly original tale of wounds and wonder salvation and swindle padre pio explores what it really means to be a saint in our time
